

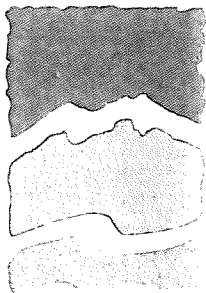

Summary regarding July 23, 2013 Regional District of Nanaimo Board Motion

On July 23, 2013 the RDN Board carried the following motion:

MOVED Director Lefebvre, SECONDED Director Veenhof, that the Board direct staff to advise Metro Vancouver that the RDN does not support a waste-to-energy facility within the boundaries of the RDN.

Following Board direction, immediately after the July 23 meeting, RDN senior staff spoke via telephone with senior staff at Metro Vancouver to advise of the above motion.

On September 17, 2013 the RDN Chair spoke in person with Metro Vancouver elected officials to confirm the above motion.

On October 22, 2013 the RDN hosted a meeting with senior staff from Metro Vancouver as well as other Vancouver Island regional regional districts, in which the above motion was confirmed.

On January 13, 2014 the RDN sent correspondence to Metro Vancouver to confirm the above motion.
